## CHIPPEWA TOWNSHIP BOARD OF SUPERVISORS PUBLIC HEARING CHESAPEAKE APPALACHIA, LLC FEBRUARY 15, 2012

The Chippewa Township Board of Supervisors held a public hearing on Wednesday, February 15, 2012, beginning at 6:45 p.m. Present were Supervisors Thomas Roberts and Nancy Lamey; Manager Mark Taylor; Code Officer Dawna Pella; Solicitor George Verlihay and Administrative Assistant Angie O'Dell. Supervisor James Bouril was absent.

Vice Chairman Roberts brought the meeting to order with the Pledge of Allegiance.

Manager Taylor noted that the purpose of the public hearing was on a Conditional Use application submitted by Chesapeake Appalachia, LLC to construct a Natural Gas Well Site in an (ARI) Agricultural Residential District located at a site owned by Antoinette Mage of 580 Achortown Road.

Court Stenographer Carol Carland was present to record the proceedings.

The following representatives from Chesapeake Energy were present: Amy Dugan, Stephan D. Ault, Amy Dobkin and Seth Shafer.

Ms. Dugan gave a detailed presentation about Chesapeake Energy drilling sites, how they are prepared and then maintained, where access roads would be, how water and other substances would be removed from the premises or put back into the ground, how horizontal drilling occurs, emergency preparedness, auditing of the site, DEP oversights, etc.
