### **PUBLIC HEARINGS**

(A) ZONING HEARING BOARD.....\$500.00

From this amount shall be deducted any fees accruing from Township consultant and/or Township Solicitor reviews. If at any time during the progression of an application, it is determined by the Township that the balance available is or will be inadequate to fully cover anticipated review costs, the applicant will be notified that an additional deposit is required equal to the first deposit. At the completion of the Land Development process any of these monies remaining on deposit with the township, after all fees are deducted, may be returned to the applicant upon written request. In any event the remaining deposits shall be returned at completion of the final project.
