# MANAGER

Township Manager Mark Taylor had the following items for discussion or action:

1. Quotes for Screening Around Dumpster Pad at Wright Fields (Turf Field Area):

Mark Taylor said this is out in the open on the corner near the port-a-johns. He said they have looked into options ranging from to \$4,510 to \$12,300. He asked the Supervisors to go over these options prior to next week's meeting. There was a discussion and there were a few questions from the Supervisors on this.

2. <u>Quote for Sign at The Point (The Digital Sign Portion is COSTARS Price):</u>

Manager Taylor and Lauren Doyle came up with some ideas for the sign. These were forwarded to the Supervisors yesterday to look over. He said they are open to other ideas, as these plans are not set in stone at this point. One option is to create the shape of the rock there. He said electric is already located in that area. The plan fits our criteria & rules. He said there will be landscaping around the rock.

3. <u>Quote for New Street Sweeper:</u>

Manager Taylor said our street sweeper was used when purchased. That was at least 25 years ago. He said employees have been fixing it and putting parts into it to keep it going. Supervisor Wright had a few questions regarding financing, costs & fees. Chairman Woodske asked if there is a fee for paying off a new one early, and he was told there is not. Eric Chaffee made comments and answered questions. He explained why he feels the Pelican brand would be a good one for the Township to purchase.
