

**CHIPPEWA TOWNSHIP

MINUTES
of the
SEPTEMBER 10, 2025
AGENDA MEETING**

The Chippewa Township Board of Supervisors held their monthly Agenda Meeting on Wednesday, September 10, 2025, at 10 a.m. Present were Chairman Dan Woodske, Supervisor Bryan Wright, Supervisor Jim Bouril, Manager Mark Taylor, Recreation Director/Assistant Manager Lauren Doyle, Code Enforcement Officer Dawna Pella, and Administrative Assistant Cindy Clark.

Chairman Dan Woodske brought the meeting to order.

VISITORS

Chief Hermick, Matt Stecklachick, Dorinda Roberts, and John Gato attended. None offered any comments when asked.

MANAGER

Township Manager Mark Taylor had the following items for discussion or action:

1. Chippewa Park Field Formal Agreement:

Lauren Doyle explained that all organizations who use the fields at Veterans Park sign a field use agreement with the Township, but there is no agreement with the school district regarding their use of Chippewa Park Field. She said we need to have a formal agreement with the school district regarding the field at Chippewa Park to avoid possible issues. She was given the go-ahead to meet and begin a conversation about this with school representatives.

2. 2025 Road Program:

Manager Taylor said that road work will begin tomorrow and work should be completed by Monday. Lauren Doyle will address any parking issues.

3. Letter From Patterson Township:

Manager Taylor had provided the Supervisors with a letter he received from Patterson Township. He explained that everyone who lives on the left side of 20th Street Extension lives in Patterson and everyone on the right side pays taxes to Chippewa Township. He said that for 30 years, the responsibility of the street has been divided this way also, with the right side of the street from the center line being Chippewa's responsibility and the left side being Patterson's. The letter he received from Patterson Township indicates that the GIS shows that COGO is in Chippewa. There is a sink hole that needs to be fixed. He has spoken to their solicitor and council members and hopes they have come up with a way to work together to resolve this problem. He said the Township and Patterson need to come up with an agreement listing who is responsible for what. He said we need something in writing. He will work on this and keep the Supervisors updated.

4. 2026 Budget:

Manager Taylor said that he will have discussions with the Township's department heads soon. Budget meetings will then be set up so that voting can hopefully be done in November. If it is not ready for the November meeting, he said it can be handled in December so that it will be taken care of before the new year.

SUPERVISORS' BUSINESS

Supervisor Jim Bouril said that the Dudo family has requested that we consider putting a 3 X 5 Gold Star flag beneath our American Flag at Veterans Park. He had pictures of these flags in other communities. This gold star on the flag represents families who have had a veteran who died in the service. The words on the flag are "Honor and Remember". They would pay for the flag. Manager Taylor said it would be fitting to put it there, but he asked who would be responsible for replacement flags. The replacement flag question, a possible time frame allotment for display, and other things will be discussed before this is decided upon.
