# CHIPPEWA TOWNSHIP BOARD OF SUPERVISORS MINUTES of the SEPTEMBER 21, 2022 REGULAR MEETING

The Chippewa Township Board of Supervisors held their monthly Regular Meeting on Wednesday, September 21, 2022, at 6:30 p.m. Present were Supervisor Dan Woodske, Supervisor Bryan Wright, Manager Mark Taylor, Solicitor Shannon Steele, Code Enforcement Officer Dawna Pella, and Administrative Assistant Cindy Clark. Chairman Bouril was not present.

Acting Chairman Dan Woodske called the meeting to order.

#### **VISITORS**

Chief Hermick and Larry Ryan attended. Mr. Ryan expressed concerns about the increase in the fee to haul trash by Valley Waste which he said was 63%. Mr. Woodske explained that the J. Young contract was up and they were sent a bid package, but the Township only received one bid from Valley Waste Service. Manager Taylor explained that the price of gas has gone up significantly and there are problems getting the man-power to work in the trash hauling business.

## REPORTS

Mr. Woodske had the following August reports for review:

#### MANAGER'S REPORT

Manager Taylor had the following items listed on the agenda for discussion:

## 1. Request for Replacement doors for the Fire Department:

Manager Taylor said he looked at the doors and determined that that although the doors seem to be in good shape, the problems are with the seals and the openers. He said the Fire Department agreed with just fixing these items.

MR. WRIGHT MOVED TO AUTHORIZE the Manager to review the upgrades to the Fire Dept. doors and allow him to approve repairs up to a cost of \$15,000. Mr. Woodske seconded the motion, and with no further discussion the motion carried.

# 2. <u>Memorandum of Understanding with BHS for Police Services:</u>

Mr. Taylor said this has already been discussed. He added that he has not yet heard back from the school regarding any adjustments that they might want to make.

MR. WRIGHT MOVED TO APPROVE the Memorandum of Understanding with BHS for Police Services as submitted to the school, contingent upon it being approved by the school. Mr. Woodske seconded the motion, and with no further discussion the motion carried.

# 3. <u>Chippewa Trails Set-aside Agreement:</u>

Manager Taylor said that the Supervisors authorized this Chippewa Trails set-aside agreement at last week's meeting. He said that our Solicitor has reviewed and approved this. The Manager has signed it. He said that Solicitor Steele will receive a copy of the signed agreement.

Manager Taylor said that all four of these amendments were reviewed by the Planning Commission and all comments were addressed.

MR. WRIGHT MOVED TO APPROVE Amendments 11, 12, 13, and 14 at Chippewa Trails. Mr. Woodske seconded the motion and with no further discussion, the motion carried.

## 8. Traffic Study for Steffen Hill and Darlington Road:

Manager Taylor explained that due to requests from his constituents, Representative Jim Marshall is asking that the Supervisors start the process to direct PennDot to complete a traffic study at the top of Steffen Hill Road and Darlington Road regarding the possibility of a 4-way stop there. This needs to come from the Township. A letter is required, with statistics attached for review. He said this will be of no cost to Chippewa Township.

MR. WRIGHT MOVED TO APPROVE starting the process to have a traffic study done at Steffen Hill Road and Darlington Road. Mr. Woodske seconded the motion, and with no further discussion the motion carried.
