MINUTES
of the
NOVEMBER 19, 2025
REGULAR MEETING**

The Chippewa Township Board of Supervisors held their monthly Regular Meeting on Wednesday, November 19, 2025 at 6:30 p.m. Present were Chairman Dan Woodske, Supervisor Bryan Wright, Supervisor Jim Bouril, Manager Mark Taylor, Recreation Director/Assistant Manager Lauren Doyle, Solicitor Shannon Steele, and Administrative Assistant Cindy Clark. Code Enforcement Officer Dawna Pella did not attend.

Chairman Dan Woodske called the meeting to order.

VISITORS

Chief Eric Hermick attended, along with Jennifer Dinterman, Larry Ryan and Ed Treliak and Joe Gianvito of KLH Engineers.

PUBLIC HEARING

At this time Chairman Woodske started the public hearing to discuss Ordinance # 269 and Ordinance # 270.

Ordinance # 269 deals with noise disturbances due to barking dogs. Manager Taylor said that the ordinance has been advertised. He said it gives definition and lays out a time frame so that offenders can be cited. It is ready to be voted on.

Those in attendance were asked if they had any comments and there were none.

Ordinance # 270 pertains to standards for maintenance of trees and shrubbery along Township property. Manager Taylor noted that a deletion under #4 had been discussed.

Those in attendance were asked if they had any comments and there were none.

MANAGER'S REPORT

Manager Taylor had the following items listed on the agenda for discussion:

1. Ordinance # 269 – Noise Disturbance Pertaining to Barking Dogs:

Chairman Woodske said that as previously discussed, this ordinance will be clearer. He asked Chief Hermick if they get a fair amount of calls at the police department regarding barking dogs and the Chief said yes. The Chief added that there had been some concern about using the state statute.

MR. BOURIL MADE A MOTION TO PASS ORDINANCE #269 REGARDING BARKING DOGS. Mr. Wright seconded the motion and with no further discussion the motion carried.

2. Ordinance # 270 – Standards for Maintenance of Trees & Shrubbery Along Township Property:

MR. BOURIL MADE A MOTION TO PASS ORDINANCE #270 REGARDING TREES AND SHRUBBERY ALONG TOWNSHIP PROPERTY. Mr. Wright seconded the motion and there was some discussion. It was decided to remove the sentence in the ordinance that refers to an arborist. All were in favor of passing the ordinance with the amendment. Motion carried. Ordinance passed.

3. C.M.O.U Police Service Agreement Between Blackhawk School District and Chippewa Township:

Mr. Wright said this was approved by the school last night. Mr. Woodske said this is for a 5-year time span.

MR. WRIGHT MOVED TO APPROVE THE AGREEMENT BETWEEN THE SCHOOL AND TOWNSHIP. Mr. Bouril seconded the motion and with no further discussion the motion carried.

4. Ordinance Pertaining to Data Centers:

Manager Taylor said that it is a good idea to be pro-active on this ordinance. He said that we currently do not have anything in place to regulate this use. He had forwarded information on this.

MR. BOURIL MOVED TO DIRECT THE MANAGER AND THE SOLICITOR TO MOVE FORWARD ON THIS ITEM REGARDING DATA CENTERS. Mr. Wright seconded the motion and with no further discussion the motion carried.

PAYMENT OF BILLS

Mr. Woodske had the October bills for review.

MR. WRIGHT MOVED TO APPROVE payment of the October bills. The motion was seconded by Mr. Bouril, and with no further discussion the motion carried.
